2.	<p>Hazards identification</p> <p>BALTEK® SB and SBC do not constitute significant risks to public health and environment if it is used as intended.</p> <p>Fine dust is produced while sawing, milling, grinding and sanding, which may pose an inhalation and explosion hazard.</p> <p>Once ignited, product will liberate Carbon Monoxide, Carbon Dioxide, and may "punk" until doused with water.</p> <p>Wood dust may cause dermatitis upon prolonged, repetitive contact; may cause respiratory sensitization and/or irritation.</p>

Fiberglass Dust (CAS #65997-17-3) for CK Format: PEL TWA=10 mg/m³, TWA=5 mg/m³ for respiration.</p> <p><i>Exposure controls:</i> The use of gloves, protective goggles and dust masks (such as TC-21C-132 approved) is recommended for sawing, milling, grinding and sanding. Where use results in generation of dust from product, provide sufficient mechanical (general and/or local exhaust) ventilation or vacuum-assisted dust collection to prevent explosive concentrations of airborne dust from developing.</p>
